From 1992 when the first guardianship was accepted, it has been assuming more guardianship responsibilities every year.

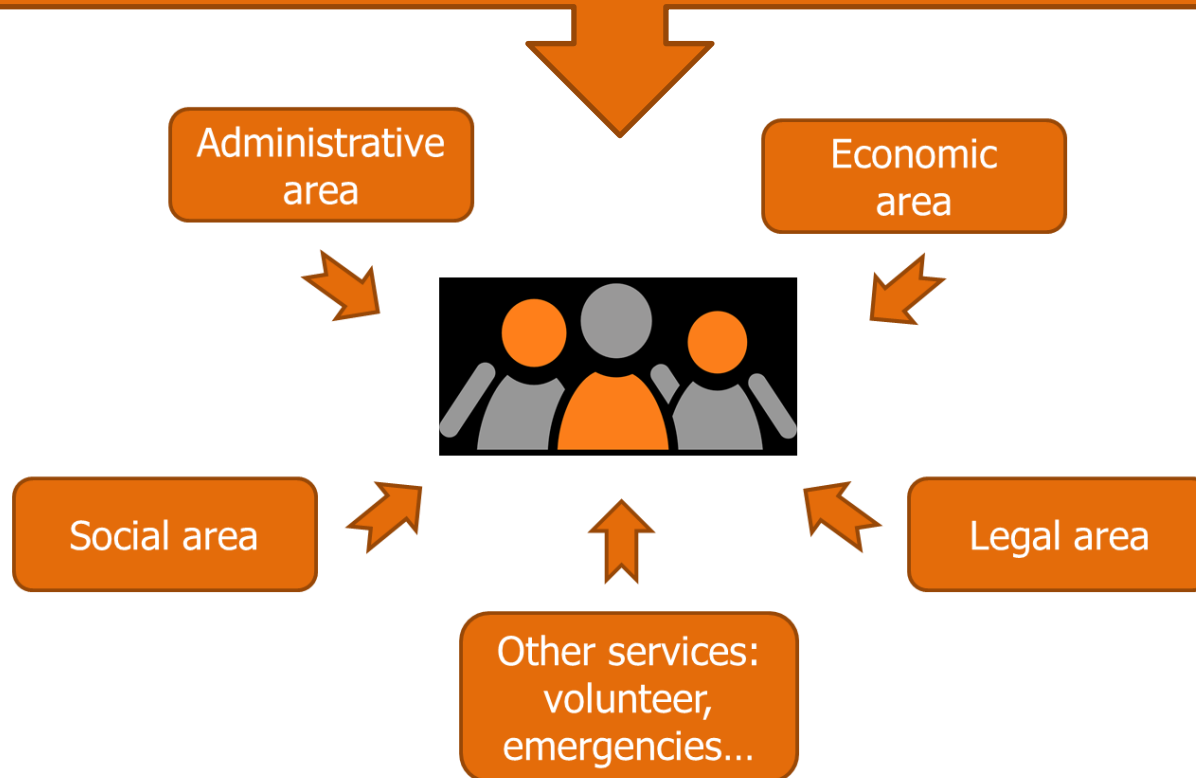

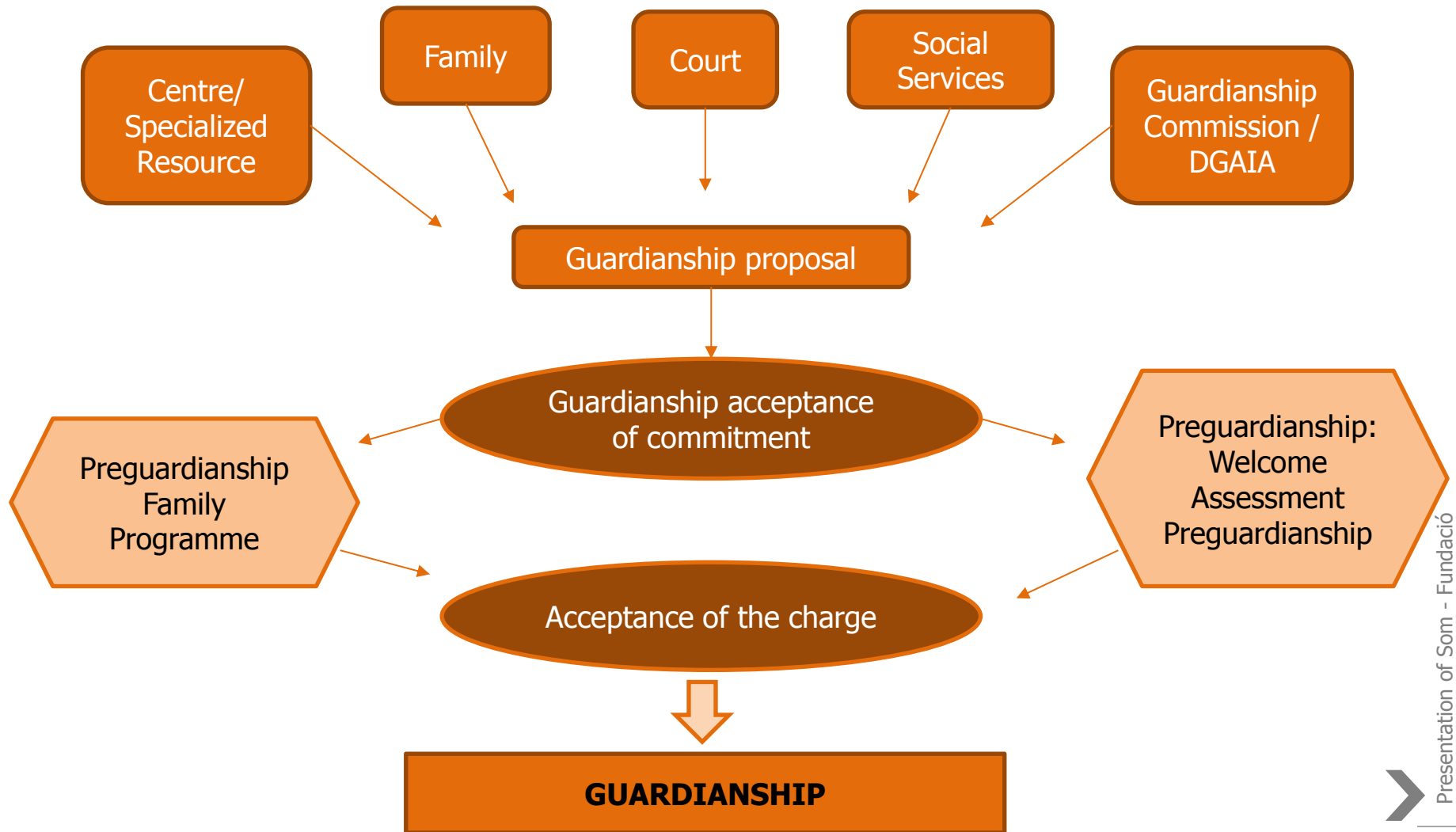
## PREGUARDIANSHIP AREA

- . Make a link with the entity.

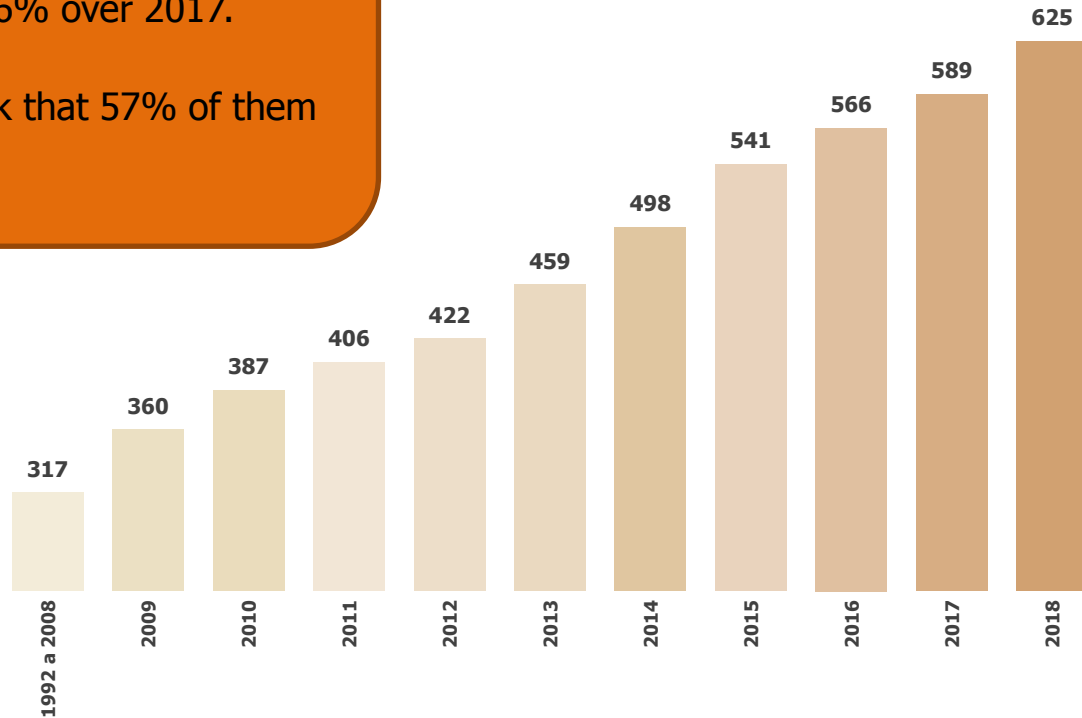




# support to people with ID

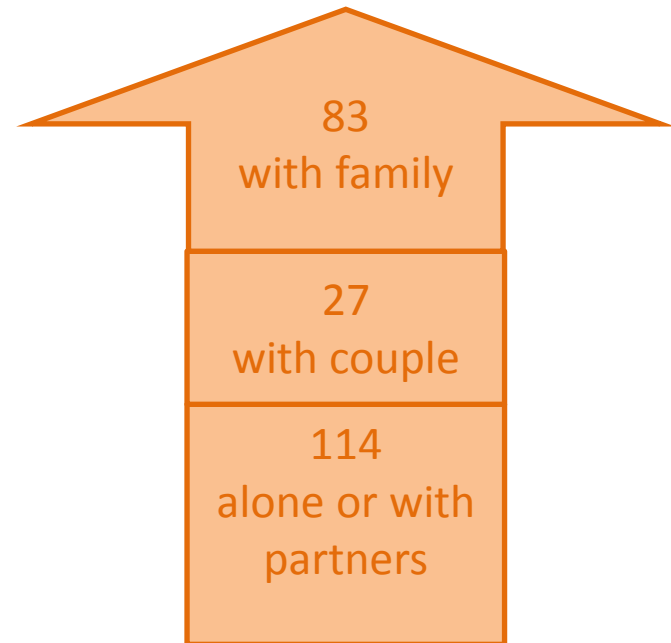
The aim of this programme is to give support and to promote the independent life of the persons with intellectual disabilities that we care, favouring their personal development, self-determination and defending their rights.

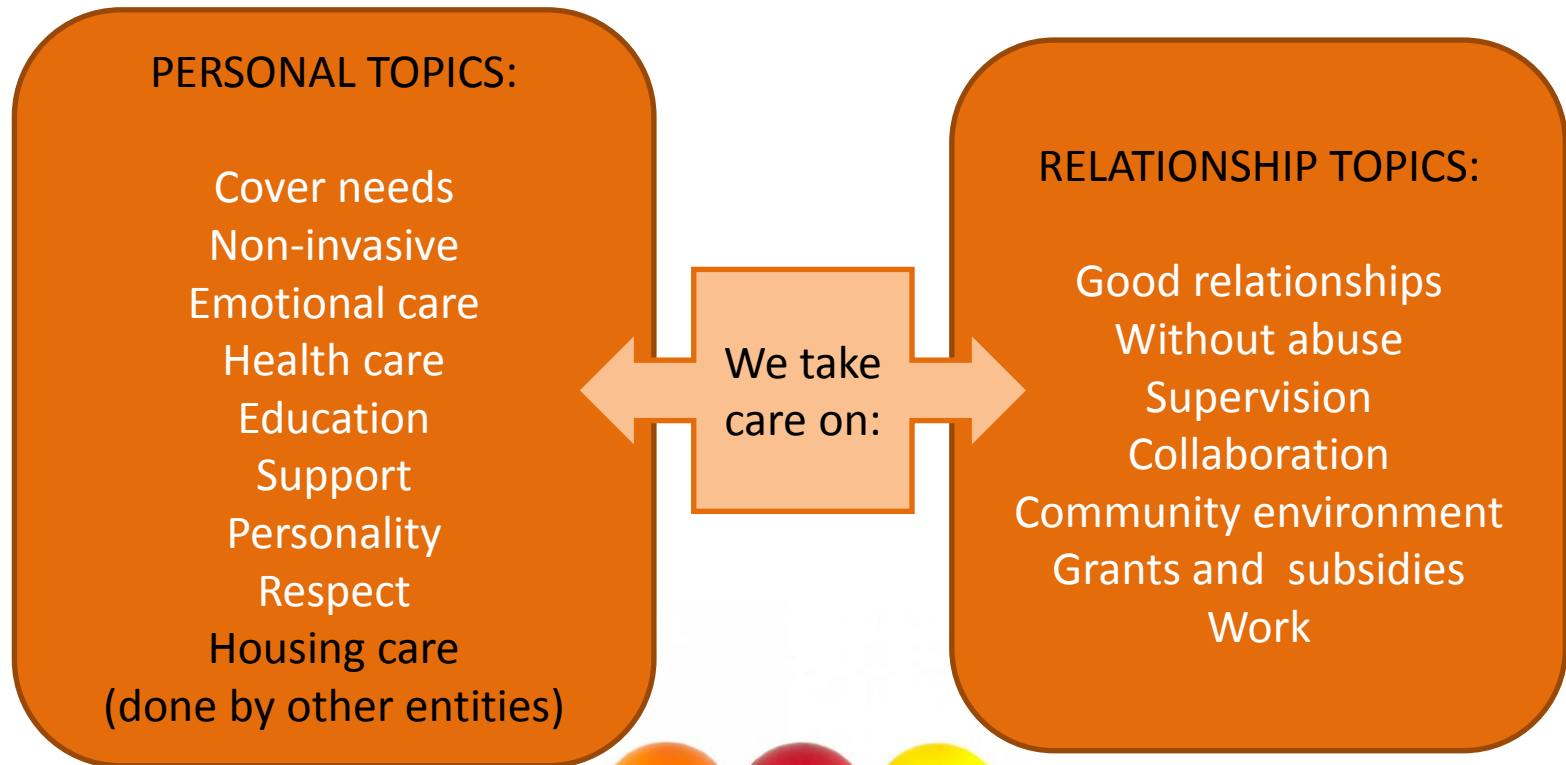
The decision of starting an independent life is contextualized according to the environment and personal situations, as well as family or social ones.

## **LOREG – Organic Law of General Electoral Regime**

On December 5<sup>th</sup>, the Organic Law 2/2018 was approved, for the modification of June 19<sup>th</sup> Organic Law 5/1985 which said on its article 3.1: "They lack the right to vote: b), those declared incapable by virtue of a final legal decision, provided that the same expressly declare the inability to exercise the right to vote."



## **LOREG modification**

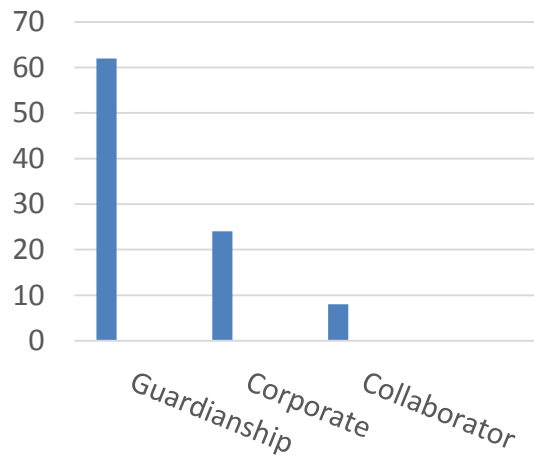
With the modification approved last December, the law is written as follows: "Every person may exercise the right to active suffrage, whatever is the way of communicating it and with any kind of support required".



Volunteering program gives the opportunity to participate in a active way on the mission of Som – Fundació to any person under guardianship, establishing a personal relationship which last on time with a person with disabilities and that enhance the capacity and the emotional well been.

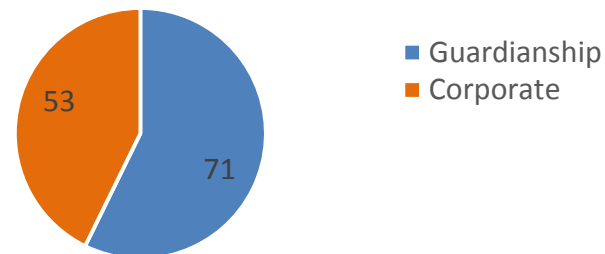


## VOLUNTEERS



On December 2018 there was 94 volunteers, of which 66% were from people who we are giving support volunteers.

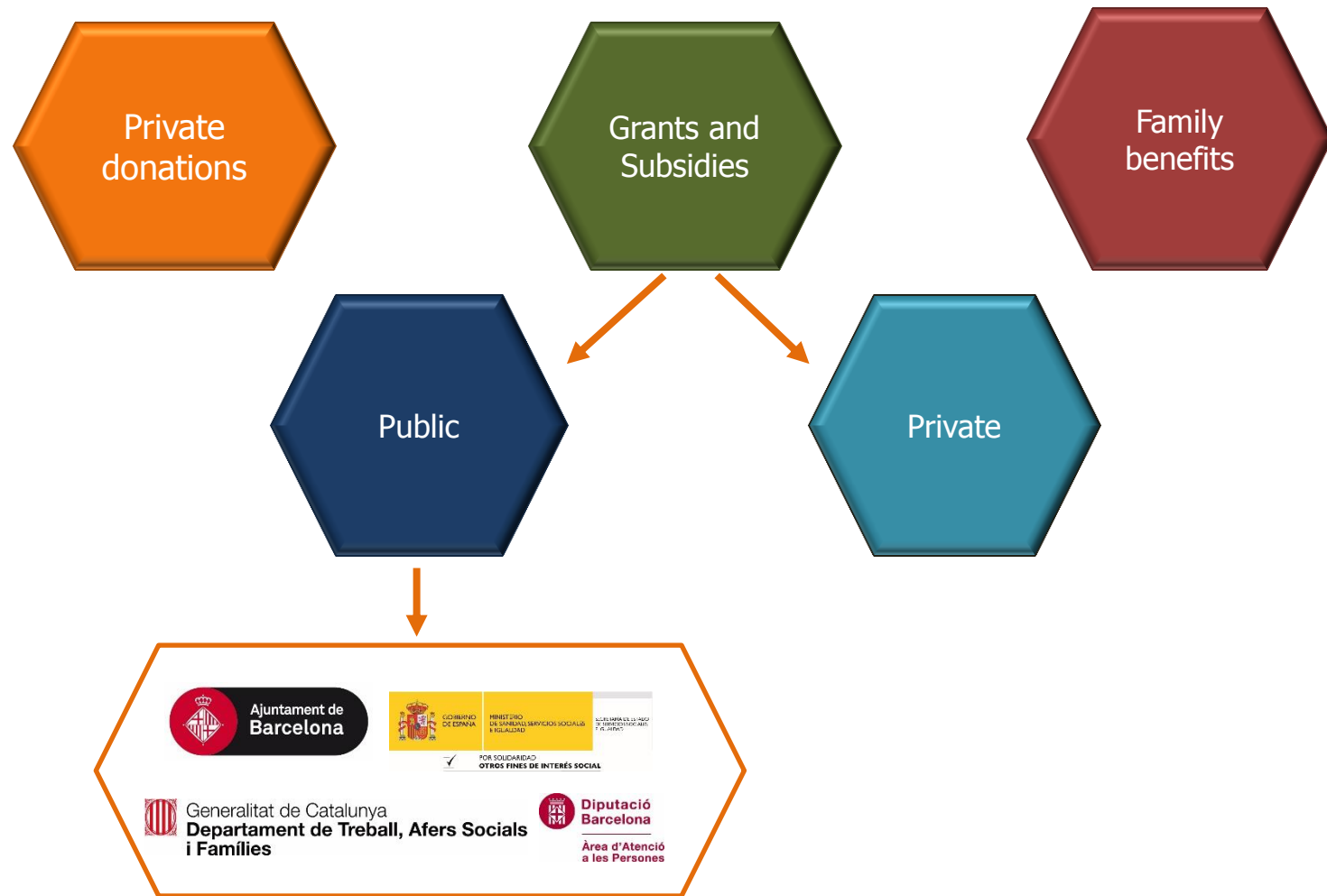

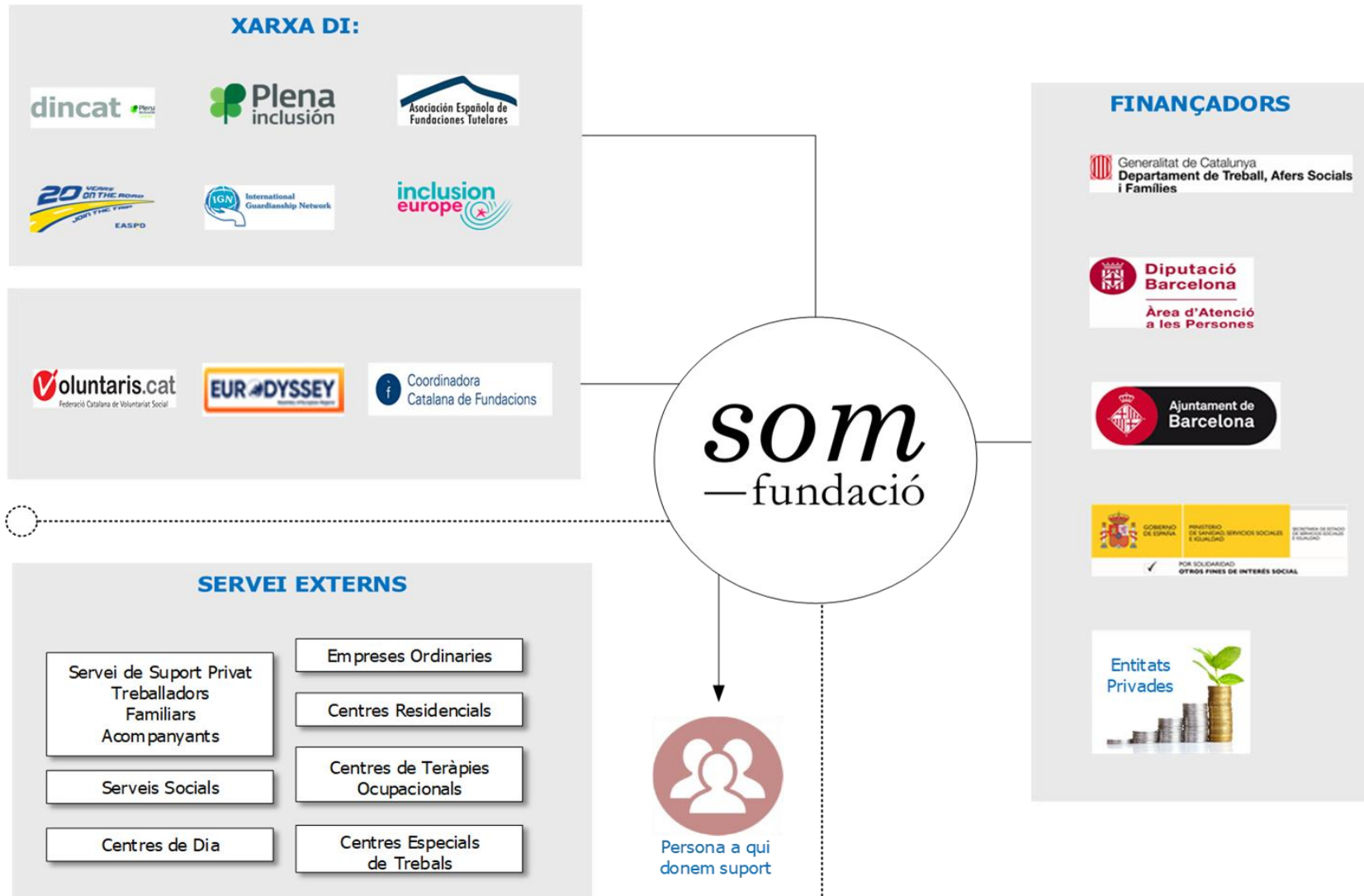

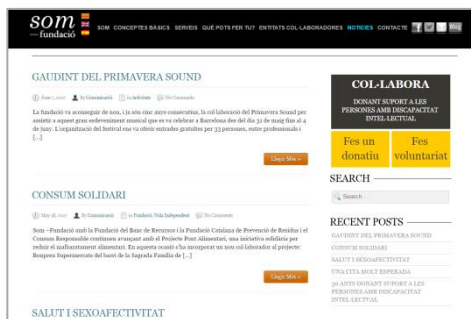
